Site Description	<p>Myspace is a social networking service with a strong music emphasis owned by Specific Media LLC and pop music singer and actor Justin Timberlake. Myspace was launched in August 2003 and is headquartered in Beverly Hills, California. In June 2012, Myspace had 25 million unique U.S. visitors. It was founded in 2003 by Tom Anderson and Chris DeWolfe, and was later acquired by News Corporation in July 2005 for \$580 million. From 2005 until early 2008, Myspace was the most visited social networking site in the world, and in June 2006 surpassed Google as the most visited website in the United States. In April 2008, Myspace was overtaken by Facebook in the number of unique worldwide visitors, and was surpassed in the number of unique U.S. visitors in May 2009, though Myspace generated \$800 million in revenue during the 2008 fiscal year. Since then, the number of Myspace users has declined steadily in spite of several redesigns. As of June 2013, Myspace was ranked 303 by total web traffic, and 223 in the United States.</p> <p>http://en.wikipedia.org/wiki/MySpace</p>
